



# Summer Day Camp 2021 Financial Aid Application

Camp Fire strives to provide financial aid to families who qualify based on income, household size, and other financial factors on a case by case basis. The application process is completely confidential and funds are awarded on a sliding scale to reduce your monthly tuition. We are unable to offer families full coverage of their program fees.

To be considered for Camp Fire financial aid for Summer Day Camp 2021, you must submit a completed application to the [Before & After School Registrar](#). **The Before & After School and Camp Namanu programs have separate applications.** Your child does not have to be enrolled in a session prior to submitting a financial aid application but it is recommended because there is no guarantee of program availability without enrollment.

Please note that it can take a couple weeks to process your application so please plan accordingly. You are responsible for all program fees that occur prior to financial aid being issued. **Camp Fire financial aid is not applied to charges retroactively.** Financial aid will be issued to qualifying families on a rolling basis as funds are available. Funds are still limited due to the financial impact of COVID-19. Please submit your application to the Camp Fire office as soon as possible.

## **Financial Aid Application Steps**

- Enroll your child in Summer Day Camp (recommended but not required).

- Completed applications will be acknowledged upon their receipt and processed within two weeks. Incomplete applications will be returned for you to finalize.
  
- If your financial circumstances change after you have submitted a completed application, you are required to let us know. If your application has not been processed yet, your change in finances will be considered during the review. If you have already been awarded Camp Fire financial aid, the award amount will be adjusted accordingly going forward. Camp Fire financial aid will not be adjusted retroactively.
